

## COMPETITION REGULATIONS

### « CourtMed »

The Centre Méditerranéen de la Communication Audiovisuelle (CMCA), association the law of 1901,

Registered under SIRET number 404 901 589 00030

France 3 Corse Via Stella

And France 3 Provence-Alpes-Côte d'Azur

(hereinafter together referred to as "Organisers")

Organise a short film competition on the CMCA website, accessible at [cmca-med.org](https://cmca-med.org) from 11 January 2024 to 15 February 2024( hereinafter the "Competition")

## ARTICLE 1. CONDITIONS OF PARTICIPATION

**1.1** This competition is free and open to individuals (university, film and journalism school students, directors and journalists) aged between 18 and 30 and from one of the countries of the Mediterranean Basin, and to legal entities such as schools, universities, distributors and production companies (hereinafter referred to as "Participant(s)").

To enter the Competition, the Participant must complete the registration form available online on the [cmca-med.org](https://cmca-med.org) website.

This form constitutes an undertaking by the Participant that the information provided is true and that the work submitted is personal, original and unpublished. The Participant must complete all the fields in English or French, except those mentioned as not being compulsory.

Participation is strictly nominative and the Participant may under no circumstances compete under several pseudonyms or on behalf of other Participants. The Participant declares that he/she has been authorised by the persons involved in the making of the Short Film that he/she submits to take part in the Competition.

Registration under a false identity or using the identity of another person, providing false information or registering under several identities will result in the cancellation of participation. A Short Film may only be submitted by one Participant.

**2.2** The audiovisual works presented deal with subjects relating to issues, culture, heritage, history, societies and the lives of women and men in Mediterranean countries.

Any audiovisual work regardless of genre and technique (fiction, documentary, report, animation, etc.) with a maximum duration of 15 minutes and completed after January 1, 2023 is eligible.

**2.3** The registration form and the Short Film must have been registered no later than February 15, 2024.

Any application received after this date will not be accepted in the Competition.

## ARTICLE 2. TECHNICAL CHARACTERISTICS

**3.1** Participants must indicate the link to watch the film in the registration form. If there is a password, this must be indicated during registration.

Any password-protected link must remain active until the selection process is complete.

**3.2** To be eligible for the Competition, audiovisual works must be in French or, in the case of another language, preferably subtitled in French or, failing that, in English.

## ARTICLE 3. AWARD

**3.1** The selection of the winning works is made by the CMCA team and a representative of France 3 Provence-Alpes-Côte d'Azur and France 3 Corse Via Stella.

**3.2** The directors of the works entered will be awarded one of the awards mentioned below:

**- The France 3 Corse Via Stella broadcast award:**

The broadcast award will be granted to one winner. He will win the purchase of his Short film for broadcast on France 3 Corse Via Stella subject to the conclusion in due form of a contract for the acquisition of broadcasting rights between the Winner or any person authorized for this purpose and France 3 Corse Via Stella.

**- The France 3 Provence-Alpes-Côte d'Azur broadcast award:**

The broadcast award will be granted to one winner. He will win the purchase of his Short film for broadcast on France 3 Provence-Alpes-Côte d'Azur subject to the conclusion in due form of a contract for the acquisition of broadcasting rights between the winner or any person authorized for this purpose and France 3 Provence-Alpes-Côte d'Azur.

**- The CMCA award:**

The CMCA award, accompanied by the sum of €500, will be awarded to one winner.

**3.4** The list of winners will be available on the website [cmca-med.org](http://cmca-med.org)

For each prize, the winner(s) will be notified in March 2024 of the prize(s) awarded to them by the Organizers.

**3.5** The directors and rights holders of an award-winning film undertake to mention their distinction on all material published for the distribution of the film in a context other than this Competition.

## ARTICLE 4. BROADCASTING AND LICENSING

**4.1** The authors and producers of the winning films authorize, free of charge, the Organizers to broadcast the audiovisual works during screenings and on the website, [cmca-med.org](http://cmca-med.org), for a period of 12 months from the date of announcement of winners.

**4.2** By accepting these regulations, you authorize the Organizers, free of charge, and for a period of 12 months, to reproduce and distribute images and extracts from the selected films for the purposes of promoting the Competition:

- on the Organizers' websites
- on social networks
- on any paper communication medium

- on the websites and audiovisual programs of our partners.

## **ARTICLE 5. RIGHT**

**5.1** The Participants expressly declare that they hold all the necessary rights to the Short Films allowing them to participate in this Competition and guarantee the Organizers against any recourse or action which could be brought against them in any capacity, during the exercise of the rights granted for this Competition, by any person who may or may not have participated in the production of the Short Film who may be able to assert a right of any nature whatsoever.

As such, the Participants expressly declare not to introduce into the Short Films any element which would be likely to violate the intellectual property rights of a third party. In this regard, they guarantee the Organizers against any recourse, action or claim, which could where appropriate be exercised, in any capacity whatsoever against them during the use of the Short Films, any third party who claims rights on all or part of the Short Films.

The Participants are solely and entirely responsible for the content of the Short Films; as such, they undertake not to use any element likely to infringe the personality rights of third parties, and declare to have obtained prior authorization from any third party whose image or name appears in the Short Films.

**5.2** Participants also undertake to comply with all current legislation, in particular:

- any provision relating to respect for private life, intellectual property law, press law, patent law, trademark law and image rights
- rules of public order, in particular the regulations applicable to pornographic and pedophile content
- the legislation applicable to minors and in particular not to integrate into the Short Films any element of a pornographic, pedophile, hateful, offensive, defamatory or, more generally, offensive to public order and good morals character
- not to insert an advertising allusion within the Short Films

Participants undertake not to send files that contain viruses. They undertake to respond as quickly as possible to any request for information from the Organizers in the event of a dispute.

## **ARTICLE 6. PERSONAL DATA**

By registering for this Competition, Participants agree to provide the Organizers with personal information. They are collected through the Competition registration form. The personal data of Participants, other than first and last names or pseudonyms, is intended solely for the Competition Organizers, and will not be communicated to third parties. They are used by the Organizers as part of the management of the Competition. They can also be used for promotional mailing purposes, and possibly mailings offering them the opportunity to participate in actions of the CMCA, France 3 Corse Via Stella and France 3 Provence-Alpes-Côte d’Azur.

It is understood that in application of law no. 78-17 relating to data processing, files and freedoms of January 6, 1978 modified in 2018, the Participant in the Competition has a right of access, rectification, modification and withdrawal of personal data concerning him.

## **ARTICLE 7. LIMITATION OF LIABILITY – INTERNET NETWORK**

Participation in the Competition implies knowledge and acceptance of the characteristics and limits of the Internet, the absence of protection of certain data against possible misappropriation or hacking and risks of contamination by possible viruses circulating on the network.

The Organizers decline all responsibility in the event of misuse or incident linked to the use of the computer, Internet access, maintenance or malfunction of the servers hosting the audiovisual works of the Competition, or any other technical connection.

It is the responsibility of Participants to take all appropriate measures to protect their own data and/or software stored on their computer equipment against any attack.

The responsibility of the Organizers and their partners cannot be engaged, in general, if for reasons of absolute necessity or fortuitous event beyond its control, the operation had to be postponed, modified or canceled.

## **ARTICLE 8. APPLICATION OF THE REGULATIONS**

Participation in the "CourtMed" Competition is free and implies on the part of each Participant full and complete acceptance of these rules and the terms of the Competition, the rules of ethics in force on the Internet, as well as the laws, regulations and other texts applicable in France.

The Organizers reserve the right to exclude from the Competition any Participant who does not fully comply with these regulations.

## **ARTICLE 9. CHANGES TO THE RULES**

The Organisers reserve the right to cancel, shorten, extend, suspend or modify the Competition, in whole or in part, if circumstances so require and without any liability on their part. These changes will, however, be the subject, as far as possible, of prior information by all appropriate means.

## **ARTICLE 10. APPLICABLE LAW AND JURISDICTION**

The rules are governed exclusively by French law. Any case not covered by the rules will be decided by the Organisers, whose decisions are final.
